HOW TO USE YOUR CLUBCARD REWARDS TOKENS

- Use your rewards tokens towards full or part payment for the Harlyn Surf School Surf Day which includes a 2hr morning lesson and hire of the equipment to 5pm in the afternoon to practice your skills.

OR

- Use your rewards tokens towards full or part payment for the Harlyn Surf School Coasteering Activity Day which includes a 2hr coasteering session and hire of a bodyboard and wetsuit until 5pm.

- Coasteering Activity Day is available on select dates from June to September 2011 and Harlyn surf day is available from Easter to October 2011. Please contact Harlyn Surf School on 01841 533076 or e-mail info@harlynsurfschool.co.uk to check availability. **Booking in advance is essential.**
- A minimum of 7 days should be allowed from the date of the booking to the date of the activity. Please post your reward tokens, any additional payment if applicable and a Harlyn Surf School booking form which can be downloaded from the website to Harlyn Surf School, **23 Grenville Rd, Padstow, Cornwall, PL28 8EX**. You will receive e-mail confirmation of your booking. Harlyn Surf School Terms and Conditions apply to all bookings.
- Rewards tokens cannot be replaced, so we recommend that you send them to Harlyn Surf School by **Special Delivery**.
- Please wear clothing appropriate to the weather conditions on the day. All surfing equipment, boards and wetsuits will be provided by the surf school. Buoyancy aids, helmets and wetsuits will be provided for coasteering, participants will need to bring an old pair of trainers or wetsuit shoes
- Minimum age is 10 years old for Coasteering and 8 years for the surf day. All participants must be able to swim 25m unaided and must be confident in the water.
- In the rare event that Harlyn Surf School considers conditions to be unsuitable for the activity you will be offered an alternative date (subject to availability) or a credit voucher will be issued.

THINGS TO REMEMBER

- "Activity Days" tokens ordered from 26 September will only be redeemable on "Activity Days" product and will not be interchangeable across other categories.
- Tokens ordered prior to this date and marked with a S code will still be accepted
- Rewards tokens **can only** be used to purchase one activity day experience per person.
- Rewards tokens can be used as full or part payment. You can use more than one reward token, but **no change will be given if the value of tokens exceeds the total value to be spent.**
- Rewards tokens **cannot** be used for group bookings of over 8 people or for private sessions
- Rewards tokens can be topped up with cash or cheque or credit card payme
- Rewards tokens **cannot** be used in conjunction with any other offer or Harlyn Surf School product
- You **cannot** pay with Clubcard vouchers or rewards tokens at the venue.
- Rewards tokens are **valid for 6 months** from date of issue.
- Once your rewards tokens have been exchanged for a taster session through Harlyn Surf School, this experience or course is **non-exchangeable** and **non-refundable**.
